



## Chingford Scouts – Chingford WSJ 100 Club – Rules

---

1. The name of 'the Club' is the Chingford WSJ 100 Club, regardless of the number of members.
2. The object of the Club is to raise funds for young people from the District to be able to attend the World Scout Jamboree in Japan 2015 and any future World Scout Jamborees.
3. The subscription to the Club for one number/share shall be £12 per year (£1 per month) payable annually in advance or by monthly standing order. This will give members one number which will be placed in 12 draws (i.e. one draw every month). Members may have and are encouraged to have multiple subscriptions.
4. Anybody over 16 years can become a member of the Club and you are encouraged to get family and friends to join. The Club shall not be limited to 100 members. The more shares/numbers we sell, the bigger the prizes!
5. There is no provision to opt in/out on a month by month basis. The normal Club year will be March to February. Members joining after the start of the normal Club membership year will be charged a pro-rata amount for the rest of the year until the end of February and entered in the next available draw following payment.
6. A member is eligible for inclusion in the draw so long as the subscription for that month has been cleared for payment and a membership form (attached) has been submitted.
7. Each member is allocated a permanent number in the monthly draw. This number shall remain the member's for the current year provided their subscription is up to date. Registers will be kept recording the name and address of each member, the number(s) allocated to them and the subscriptions received from them.
8. Members wishing to leave the Club should do so at the end of the Club membership for that year. Refunds will not be given for people wishing to withdraw before the year end.
9. There shall be one prize draw per month. The draw for each month shall be made as close to the end of each month as arrangements reasonably allow. The draws will be made in the presence of at least three people.
10. The regular monthly prize fund will be 50% of the monthly income. There will be three prizes:
  - 1st prize = 50% of the monthly prize fund (£25 if 100 numbers)
  - 2nd prize = 30% of the monthly prize fund (£15 if 100 numbers)
  - 3rd prize = 20% of the monthly prize fund (£10 if 100 numbers)The remaining 50% of the income will be allocated to the Chingford District Scout Council WSJ fundraising account.
11. The Club will operate as a Small Society Lottery as defined by the Gambling Act 2005. Chingford District Scout Council is the Promoting Society and is registered by the local licensing authority, the London Borough of Waltham Forest. The organiser is Julie Leverington, 169 Old Church Road, Chingford, London E4 6RB.
12. The allocation of numbers and draw results will be available from Julie Leverington or members of the Chingford District Scout Council on request. The results can be e-mailed if required. Prize details will also be published on the Chingford WSJ website each month after the draw ([www.chingfordwsj.org.uk](http://www.chingfordwsj.org.uk)).
13. The Club administrators will make all reasonable efforts to pay or post prizes to the winners within a reasonable period after the monthly draw. Contact details used will be those from the member's application form or amendments subsequently advised to the organisers.
14. If a winner cannot be contacted, the winnings will be placed into the Chingford District WSJ funds after 6 months.
15. If the Club should be wound up, members will be notified, all outstanding draws will be held immediately and the relevant prizes will be paid before it is closed.
16. Unless otherwise advised, a member will be deemed to have left the Club if his or her renewal of subscription remains unpaid for a period of one month.
17. The Chingford District Scout Council shall have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 100 Club members as is necessary.
18. The decision of the Chingford District Scout Council shall be final in all matters requiring adjudication.
